10:00 a.m. – 10:45 a.m. Committee Meetings.

10:45 a.m. – 11:45 a.m. Public Safety Broadband D-Block/LTE Presentation: by Keith Kemmerline, Motorola Solutions Team. A presentation directed towards our more technically-minded members on the issues of public safety broadband and the D-Block.

Noon Lunch Sponsor: Sound Communications.

1:00 p.m. Membership Meeting: Ohio APCO President, Michael Banks and Ohio NENA President, Anne Barr called the meeting to order at 1:00 p.m. followed with the reciting of the Pledge of Allegiance. Roundtable introductions were by-passed to assure time availability for today's meeting.

OSP Blue Alert Notification System Presentation: by Lydia Frey and Rob Jackson from Ohio State Patrol. Blue Alert is an Amber Alert-type warning system for police. A "Blue Alert" would be broadcast to let Ohioans know when a law enforcement officer has been killed or injured and the suspect has not been captured. There are two criteria for a Blue Alert to be issued.

1) A local law enforcement agency confirms that a law enforcement officer has been seriously injured or killed, and a suspect has not been apprehended, or that a law enforcement officer is missing while on duty under circumstances warranting concern for the law enforcement officer's safety.

2) There is sufficient descriptive information about the suspect or the circumstances surrounding a law enforcement officer's injury,

death or disappearance to indicate that activation of the alert may help locate a suspect or a missing law enforcement officer.

NORIS users will not be included in automatic notifications at this time due to NORIS programming issues. Agencies using NORIS should call 614-466-2660 to report Blue Alert Notifications until issues can be resolved.

Secretary's Report: by Danielle Klavinger. *NOTE: minutes are available for review on the Ohio APCO website.* A motion to waive the reading of February's minutes and to accept them as written was made by Jay Somerville, seconded by Alan Fish, with no further discussion and no one opposing, the motion carried with all in favor.

Treasurer's Report: by Danielle Klavinger. Balances as of April 30, 2012: Chapter checking-\$12,176.48, Chapter money market-\$16,996.05, Gold Star/Conference checking-\$8,500.22. A motion to accept the Treasurer's report was made by Kim Brant, seconded by Brad Brubaker, with no further discussion and no one opposing, the motion carried with all in favor.

SIEC Update: by Matt Franke. On April 18, 2012, Governor John R. Kasich signed Executive Order 2012-07K formally establishing SIEC. Beginning in 2002, holding regular meetings, special sub-committee meetings and accomplishing a great deal to aid and benefit Ohio's public safety community, the Ohio Statewide Interoperability Executive Committee (SIEC) became official. Matt foresees SIEC becoming more involved in Statewide Interoperability issues in the future.

700MHz/800MHz/AFC: by Paul Mayer.

VHF-UHF Narrowbanding – 236 Days till Jan 1, 2013 deadline. DHS/OEC Website shows 53.3% Licenses covering 60.3% Transmitters modified for NB. That does NOT mean the work has been done, just the license mods. If anyone has a question about their agency, please contact Paul. 700 MHz - Paul and Matt Franke attended the annual 700/800 RPC Workshop in Tam-

pa April 24-25. Received updates in Regional Plan status, Organizational, FCC, CAPRAD, Legal and Public Safety Broadband issues and elected new officers. **700 RPC Annual meeting in conjunction with the September 12th APCO/NENA meeting 10:30AM here at the Holiday Inn.**

800 MHz -MARCS Mutual Aid back to back repeaters in place. MARCS BDA's have been upgraded in Columbus, Cleveland and certain prisons. Mobile Data Systems well over half of the VRM's (OSHP-ODNR) have been completed, ODRC & ODYS subscriber units are being worked now, nearly half done. Site on Wheels (courtesy of Sprint) is under construction, will be delivered soon (needed for DRC Site reconfiguration). After the rebanding project is done, the SOW will belong to MARCS and will be available to respond to local emergencies where additional channel capacity is needed. **SCIP Update** -Meeting Tuesday May 15th 10 a.m. at the EOC.

TERT Committee: by Ken Stewart. A line of communication has been established with EMA. Nothing new to report at this time.

Commercial Advisory Committee: by Chris Zigo: Thanked Sound Communications for sponsorship of today's luncheon. Encouraged commercial members' participation at the 2013 Conference. Vendors were asked to contact Chris or Michael Warren with any input or questions.

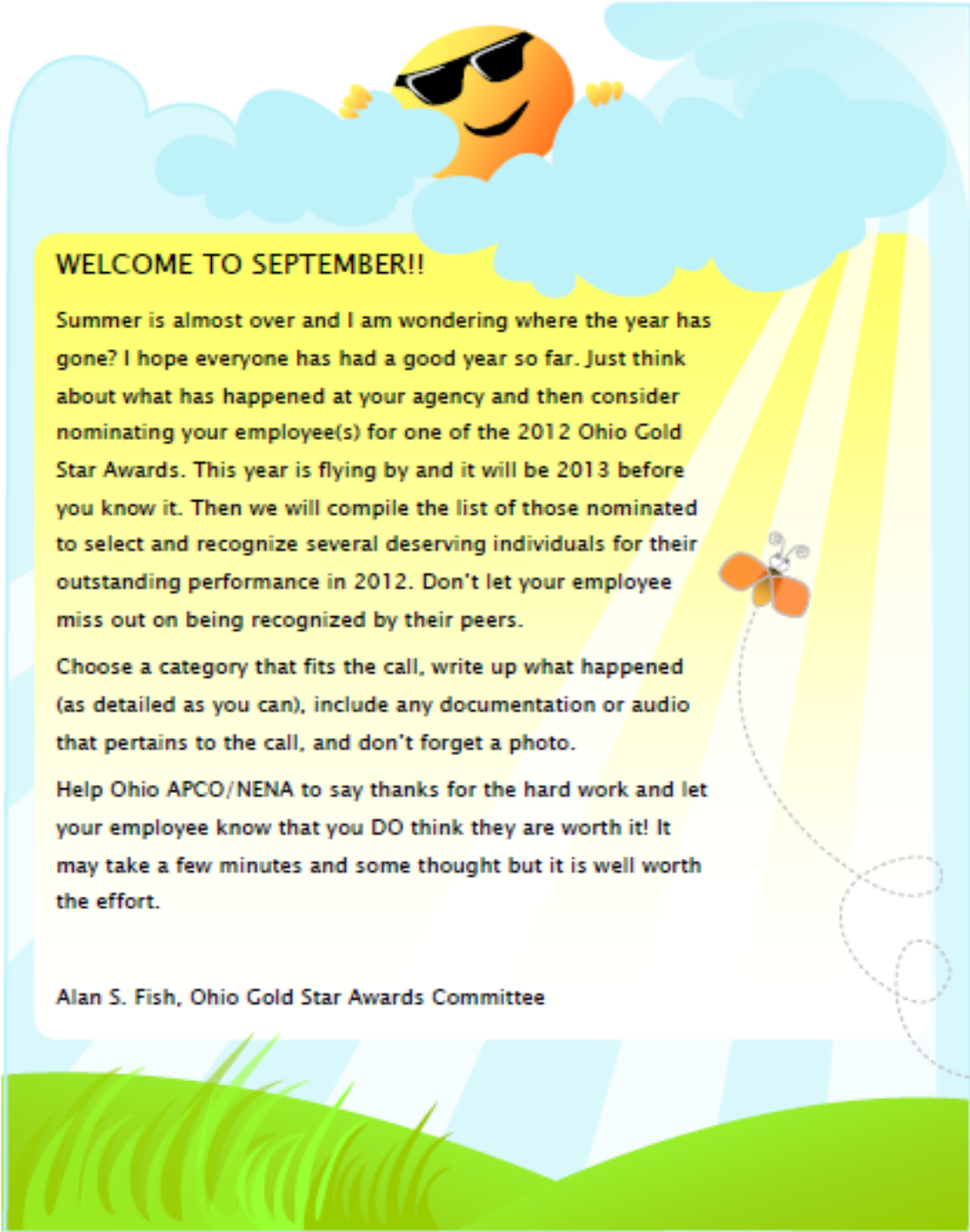
