If my 28 years in public safety communications have taught me anything, it is that there is no better avenue for learning and professional development than being an active member in Ohio APCO and APCO International. When I was first approached by Lynne Feller while attending a training class at Wayne County in 1987, I had no idea what a membership in APCO had to offer a guy just starting out as a telecommunicator. I can still remember filling out the application the next night and sending in my \$25 for the membership and thinking, "well at least I get a magazine about dispatching". That initial \$25 turned out to be the best investment I ever made in my career. This organization is about people. Launch of AppComm

On April 23, 2013, APCO launched the Application Community – "AppComm" – a new website dedicated

to public safety and emergency response apps. AppComm is the single, trusted online forum where

public safety professionals, the general public, and app developers can rate and comment on apps,

submit ideas for new apps to serve public safety needs, and suggest additional apps for inclusion on the

site. APCO immediately received praise from U.S. Representatives Anna Eshoo and Doris Matsui, as well

as public safety professionals. AppComm (www.appcomm.org) will help APCO continue its leadership

role in fostering app development.

Narrowbanding

FCC reports than more than 10,000 public safety licenses are not in compliance with narrowbanding. They also remind licensees and coordinators that there is still time to bring these licenses into compliance. The Commission also reiterates that licensees whom have not complied with narrowbanding mandate will face cancellation of their license and possible fines up to

\$116,000. The Commission also reminds frequency coordinators that those licensees operating in 25

KHz bandwidth (wide band) will be protected as if operating in narrowband mode. The Commission will

conduct an audit to cancel those licensees with wideband emission designators (i.e., 20K0F3E). For

further information and details on this very important public notice, refer to DA 13-376.

700 MHz, 4.9 GHz, and 90.187 Trunking NRPMs

The FCC recently released three much anticipated Notice of Proposed Rule Makings. The trunking rulemaking modifies the current rules (as recommended by LMCC) to base assignment of channels on nonoverlapping for service and interference contour in lieu of 113 km distance separation. The FCC also

now requires reverse engineering analysis and affords protection to mobile only licenses by defining the

service area of operation as both service and interference contour.

700 MHz NPRM defines and clarifies regional planning roles and provides instructions to RPCs on plan

changes and meeting announcements. The Commission also seeks comments on the requirement to

migrate to 6.25 KHz operations in 700 MHz band. These are some of the points covered in the NPRM

and there are other important rulings which do affect coordination and 700 MHz licensees. 4.9 GHz seeks comments on a number of issues such as band plan, coordination, point-point use, and

aerial use. NPSTC has established a 4.9 working group to formulate a national band plan for 4.9 GHz.

APCO will be chairing the frequency coordination working group.

Legislative Report: Jay Somerville; The ESINet Steering Committee still needs two signatures before delivering the report to the Ohio Legislature by the May 15th deadline. Once submitted, the report will be posted online at the Ohio Chapter website. Jay reminded attendees that the report is not a roadmap to implementation of next-gen. It is only in response to questions asked by the legislature. Implementation has only just begun. Be sure to keep an eye on the Ohio Chapter website for further updates on HB59 which if passed will address several changes as they relate to 9-1-1 i.e. defining the steering committee within the statute, defining and designation of the ESINet Steering Committee, removing 9-1-1 services from the PUCO and into the Department of Administrative Services, discontinuing the wireless fund and revising PSAP funding and distribution.

 Operational and Technical Standards for PSAPs are to be established and presented by January 1st 2014.

<u>SIEC Upddate:</u> Matt Franke; Governor designated SIEC an executive committee by executive order. The sub-committee is actively working on the radio broadband initiative. Updated attendees regarding SIEC's involvement in the 9-1-1 next-gen initiative. Encouraged PSAPs to get involved and take advantage of Regional SIEC meetings.

700MHz/800MHz/AFC: Matt Franke as Paul Mayer was unable to attend. FCC reported not all public safety licenses are in compliance with narrow banding. The FCC stated licensees whom have not complied with the narrow banding mandate will face cancellation of their licenses and possible fines. The commission will be conducting audits (TBA) and licenses canceled.

DHS/OEC and SPAWAR are going to be in Columbus to assist with the comprehensive Statewide Communications Interoperability Plan, on Wednesday, June 26 and Thursday, June 27. Additional information posted on the Ohio APCO or SIEC website. One representative from each of Ohio's 88 counties is needed to begin the process.

Report submitted by Paul Mayer as he was unable to attend the meeting;

- Activity to report usual VHF-UHF activity, upgrades, expansions, etc.
- 700 MHz MARCS continues to roll out sites, 38 sites licensed and on the air, another 55 more sites filed, pending and under construction.
- 800 MHz agencies around the state in various stages of rebanding with many already done. MARCS Infrastructure will start to re-band in late Sept., early Oct. Expect to take approximately 3 months for all 218 sites.

- If anyone has any MARCS radios that have not had their 1st touch, contact the MARCS office. There should be a blue sticker of some sort on the back or under the battery.
- Bob Bill was in Washington at FCC
 HQ yesterday for a training class on
 ENVIRONMENTAL AND HISTORIC PRESERVATION COMPLIANCE. Today he is at the FCC
 Licensing facility in Gettysburg attempting to understand that process.
 We both will be attending the Conference in Anaheim; Bob will go to
 APCO HQ in September for Advisor
 training.

Chapter Leaders Training at APCO 2013

Each year, in conjunction with the annual conference, the Member & Chapter Services Committee (MCSC) presents the Chapter Leaders Training Course. This year, in Anaheim, the session will be presented on <u>Sunday morning</u>, <u>August 18 from 8:00 AM – 11:00 AM</u>.

You do not have to be a Chapter Officer to attend this training! It has been defined as a mid-level training course for individuals who are interested in becoming more active and more engaged at the chapter level, with the hope that the individual will eventually become an engaged participant at the international level of the association.

The chapter leadership course is the evolution of what started in the year 2000 as the work of the Chapter Enhancement Taskforce. Then President Lyle Gallagher saw a need for improved relations between the parent organization of the Association of Public-Safety Communications Officials - International, Inc. (APCO) and the local chapters across the nation. The Chapter Enhancement Taskforce developed into the Member & Chapter Services Committee (MCSC), a standing committee of APCO International that maintains relationships with the chapter officers, keeping them informed of membership issues and association programs, and seeking input and feedback from those individuals that run the operations of the local chapters.

The subject areas that have been chosen for this course will give the individual a deeper understanding of the association's workings and how the chapters are a vital part of those operations. Topics include governance, membership structure, chapter organizational structure, recognition and awards, Life and Senior Member designations, scholarships, use of the logo, and more.
