Ohio 9-1-1 Program Office - Patrick Brandt

NG 911 progressing learned yesterday that we'll have hosted servers in by the end of this month at Columbus/Cleveland datacenters. As of today, the plan is to switch first county over at the end of August in one of the pilot counties. Backbone is set up, still working on items with Oarnet, 64 counties have identified they want to come over to the statewide system. 12 counties have identified that they want to come to the hosted solution.

Cyber security email, thanks to everyone who wanted to be involved. They are trying to get additional money from the feds to do more of the reviews.

GIS data, if you have polygons for your PSAP please get them submitted to the 911 Program Office.

County plans, there's been complaints on the makeup of the boards. Our office has read every plan that has come in, some do not meet the ORC. Some have been missing 2 of the 6 required seats, which still meets the majority requirements. The office is willing to help assist counties with completing these plans.

It's important to get financial reports in and accurate as this is what the device surcharges are based on.

The FCC survey is out, the state auditors are looking at this as well, they are trying to find their proof on funding and how we are dealing with this.

Mission Critical Partners has a 'best practice on mitigating swatting' incidents coming out. 988/911 webinar PEGS foundation?

HB 321 - 3rd/4th hearing the other day, proponent hearing, that's still in committee. This bill is intended to create a statewide special needs database.

APCO AFC - Devan Phillis

Devan Phillis introduced himself as the new AFC representative and coordinator. Bob Bill is retiring, and Devan will be assuming his duties.

Executive Council – Johnna Gonzalez-Sells

Attended 9-1-1 goes to Washington. Federal talking points: generating revenue for nationwide NG 9-1-1 legislation, part of the federal allocation act. Have spoken to a couple of our senators and congressmen. 9-1-1 saves act HB 6319 SB 3526, which is attempting reclassification of the dispatcher profession at the federal level. Moving to protective service classification and out of the clerical level. It will help obtain benefits like other first responders, and retirement opportunities. Looking to "Noah's Ark" this through the federal level with bipartisan sponsorship. Sounds like this bill has good bipartisan support, and it's a "feel good measure" to keep moving forward.

Working with the governor's office to get more attention to try to get them interested in touring our centers and attending our meetings so that they can get a better glimpse of our profession so that they can speak more authoritatively on the lifesaving work of our emergency telecommunicators.

Constitution and Bylaws - Cheryl Pratt

President Pratt read constitution and bylaws amendment resolution 2024-01:

Resolution 2024-01, a resolution to amend Article IV Section 4.1 of the Constitution and Article IV Section 1.7 of the Bylaws of the Ohio Chapter of APCO.

Constitution amended statements to read:

- "4.1 The President, First Vice-President, and Second Vice-President shall be elected for a term of two (2) years". Bylaws amended statement to read.
- "1.7 Bi-Annually in the final meeting of the calendar year appoint no less than three (3) nor more than five (5) Past Presidents to serve as the Nominating Committee".

In accordance with the procedures established in Article V Section 1 of the Constitution of the Ohio Chapter of APCO, this resolution will be presented to the quorum at the September 11, 2024, chapter meeting for discussion and vote. A two-thirds (2/3) majority vote or more is needed for passage.
